5	PREVIOUS MEETING MINUTES AND BUSINESS ARISING
	<p>Minutes of meeting 1 June 2022 were endorsed by BD and seconded by AL.</p> <p>Committee spent time acknowledging and reflecting on former CCC member Sharyn Cullis (Anderson) who sadly passed away on 10 June 2022. On behalf of the Committee MA had written a note of gratitude prior to her passing when she had relinquished her position on the committee due to ill health (attached to minutes). A certificate of appreciation signed by IMC Vice President of Operations (and flowers) was sent to Sharyn shortly before her passing. The booklet at her service was passed around the Committee. The CCC acknowledges Sharyn's lengthy and valuable contribution to the committee over the last decade.</p> <p><u>Questions on Notice Tracker (AL)</u></p> <ul style="list-style-type: none"> • Report to CCC the outcomes of arborist survey on the OGT (Old Growth Trees) and scope for future fencing (AL). <p>AL – IMC had engaged an arborist to survey the OGT, record those that have fallen and identify the number of trees without fencing. IMC has received the final report recently and is reviewing the recommendations. An update will be provided at the next meeting. (ACTION) A total of 64 trees assessed with most indicating termite damage.</p> <ul style="list-style-type: none"> • MA seek acceptance of March 2022 Minutes <p>MA noted this has not been completed and requested if committee can review and endorse over email (ACTION)</p>

6 OPERATIONS UPDATE

Longwall 709

AL – Provided an operations update. Longwall 709 commenced in February 2022 and has extracted 718m as of 18 July 2022. Approximately 1.8km remaining with forecast completion in Q4 2023.

SD – Has South32 contributed to the cost of the repairs to Menangle Road over the last few years?

AL – There is an arrangement for repair of Menangle Road with council if mining has caused damage to the roads. Will look at the details of the process with council for next meeting **(ACTION)**.

Longwall 904

AL – Commenced 20 May 2021. As of 18 July 2022 – progressed 2,028m.

Looking to complete the longwall in late July and prepare for changeout to Longwall 905.

PC – How long does it take to get to the longwall face underground?

AL – Approximately 40 minutes. We recently took the Menangle Advisory Panel underground and feedback was very positive. AL to arrange an underground tour for the committee members **(ACTION)**.

BD – Can you include the roadways on future maps?

AL – Yes.

7 ENVIRONMENT UPDATE

CS provided an update on the environment:

Water Treatment Plants

Long-term Plant

Continued delays have been experienced due to:

- Wet weather – that has impacted critical outdoor activities.
- COVID-19 – personnel sick and in isolation.
- Supply chain – worldwide semi-conductor shortage needing alternative design and source of spare parts.
- Faults with transformer/kiosk when installed that has resulted in delays in energising the plant.
- A meeting was held with the EPA on 7 July 2022.
- A licence variation has been submitted to the EPA to extend the date for completion.
- Trial to be undertaken to use concrete settling tanks for backwash treatment.

Temporary Plant

The volume of permeate discharged to Brennans Creek since commissioning is 177ML. New membranes were flown in from Canada as existing membranes had failed. CS notes a world-wide shortage of membrane parts.

Brennans Creek Dam

Overflow from BCD commenced on 24 February 2022 and ceased for approximately 3 weeks. It recommenced on 2 July 2022 and has continued since that date. Over 430mm of rain fell in four days. The discharge continues at maximum rates (approximately 3.5 ML/day) and BCD discharge current EC is 1.4ms/cm, pH 8.3.

The dam level is currently over 12.5 metres (height of spillway).

BD – Interested regarding quality levels and whether excess silt on bottom of dam is the result. Have you thought about draining the dam to clean it out?

CS – We are exploring opportunities to dredge. Firstly, we want to assess the amount of sediment within the dam and also conduct a contamination assessment. We are looking into a package of works to undertake this. The water in BCD is used in the washery and underground and therefore it is unable to be drained as the water supply needs to be maintained.

PC – Do you suspect that the dam is contaminated?

CS – Prior to the installation of the floating offtake pump, higher levels of heavy metals in the water had been recorded. It is possible this is still the case; therefore we will undergo the appropriate assessments.

Georges River Remediation Plan

The catchment has been closed or access limited since 9 December 2021 due to wet weather, with the exception of a three week period in June and therefore there has been no progress on the trial at WC21.

VENM Import – Appin North

Import of virgin excavated natural material (VENM) commenced in December 2021. Approximately 40,000 tonnes was imported for use as capping material on the coal wash emplacement area. This project has now been completed.

Rehabilitation

Rehabilitation Management Plan was finalised in June and is available on the IMC Website. Link below:

Rehabilitation Objectives have been submitted to the Resources Regulator Portal. Once approved, the Rehabilitation Criteria will be submitted. This will hopefully be happening in the next couple of months.

Management Plans

Environmental Management Strategy – Consultation with Wollondilly Shire Council.

Air Quality and Greenhouse Gas MP – Consultation with EPA.

Waste Management Plan – Submitted to Department.

Noise Management Plan – Consultation with EPA and WSC.

Closure Investigations

Preliminary Site Investigation undertaken for contamination. Targeted Site Investigation planned. Heritage Assessment undertaken.

BD – Whereabouts was the Heritage Assessment done?

CS – It was done across all sites.

Audits

ISO 14001 audit undertaken in June. No non-conformances identified. Triennial Independent Environmental Audit planning is underway, with IEA report to be provided by the end of 2022. The CCC will be contacted by the consultant as part of the IEA process.

Annual Review

Annual review reporting period has commenced.

***Persoonia hirsuta* Translocation**

Three *Persoonia* translocations have been undertaken at Appin North. 128 plants stage 1 – 2019. 90 plants stage 2 – 2021 and 102 plants stage 3 – 2022.

The plants in the third translocation were planted in the *Persoonia hirsuta* Offset Area.

PC – How are the 1st plantings coming along?

CS – 1st plantings not so well, seems to be drought impacted. It was a trial stage and different planting techniques were applied. We applied the learnings from this trial to the 2nd and 3rd plantings with greater success. It seems the greater success rates are from seedlings as opposed to cuttings.

Nepean River Gas Zones

There are 7 active gas zones – 6 at the AA9 end of river and one at the AA7 end.

8 S32 WEB PORTAL

AL – Reminder of new portal. This portal includes interactive maps of our mine plans that are easily accessible. It provides the opportunity for feedback and communication.

Landholder Portal: Extraction Plan

South32 Illawarra works closely to support landholders who are affected by our operations.

This portal offers to all landholders in the near future mining areas the option to individualise online support for their property to co-develop their specific Property Management Plan, discuss potential impacts relating to subsidence and arrange potential surveys and monitoring during active periods.

This portal will be completed and operating the first week of August 2022 and offered to the landholders in the Extraction Plan area and approved extraction area.

The goal is to reach in first instance the landholders affected by LW905 and LW710B.

9 EXPLORATION UPDATE

Currently operating 4 x drill rigs, they are located within EL8972 and A248. Drilling to continue around Menangle Road, Picton East, Cawdor and Razorback. The Aeromagnetic survey (helicopter) is now completed.

SD – Has there been any outcome on the drilling on the Mount Taurus Property since last year? Will this impact the proposed development?

AL – There is potentially further exploration required in the area. IMC has previously indicated that its preference is to undertake mining prior to any proposed surface development within our approved area to mine (BSO Consent boundary).

10 APPIN MINE VENTILATION AND ACCESS PROJECT

The construction schedule is that early works shall begin July 2022 and primary works will be done Q1 2023. These dates are subject to change and only an indication at the moment. PC – Why is there a helipad on site?

AL – This is used for emergency purposes only and could be used by emergency services for events in the community. Helipad is designed to meet CASA guidelines.

SD – Can South32 re-surface Menangle Road from the creek (Foot Onslow Ck bridge) to Finns Rd intersection? This would be a minor extra cost imposed on South32 given the scale of their operations and a positive goodwill gesture for the community.

AL – This is not currently in scope. This would fall under council jurisdiction. But I can raise this point to the Project team.

There was a Community Information Day held on 2 July 2022. Attendance hampered by heavy rain. Priorities amended to assist in local sand bagging.

11 BSO COMPLAINTS

The Bulli Seam Operation has received in total no complaints since last meeting.

5 enquiries received – 4 regarding Appin Memorial, 1 regarding current mining in relation to property.

12 COMMUNITY UPDATE

South32 has donated \$600,000 to help support the flood response and recovery efforts in New South Wales. The donation will be split between the Salvation Army to assist its frontline emergency response and to the Red Cross to assist with recovery and building community resilience to future disasters and emergencies.

Summary of Submissions

Broadly, supporting submissions recognised;

- Importance of the Project to the continuation of the Dendrobium Mine and ongoing employment.
- Importance of the Project more broadly to IMC and the Southern Coalfield economic ecosystem.
- IMC's revised mine design which reduces potential impacts and address the concerns of the IPC.

Broadly, key issues raised are consistent with those for the previous application such as;

- Surface water losses
- Potential impacts to biodiversity
- Amenity Impacts.
