2. In the list of DEFINITIONS, in the definition for “Department”, delete “and Environment” and replace with “, Housing and Infrastructure”.
3. In the list of DEFINITIONS, delete “DPE Water” and its definition, and insert the following in alphabetical order:

NSW DCCEEW – Water Group	Water Group within the NSW Department of Climate Change, Energy the Environment and Water

4. In Schedule 2 onwards, delete all references to “DPE Water” and replace with “NSW DCCEEW – Water Group”.
5. In the list of DEFINITIONS, in the definition of EP&A Regulation, delete “2000” and replace with “2021”.
6. In the list of DEFINITIONS, in the definition of “Minister”, after “Planning” insert “and Public Spaces”.
7. In the list of DEFINITIONS, after “Modification 9” and its definition, and before “Mtpa” and its definition, insert the following:

 - (b) after “Modification 9”, insert “and Modification 10”.
